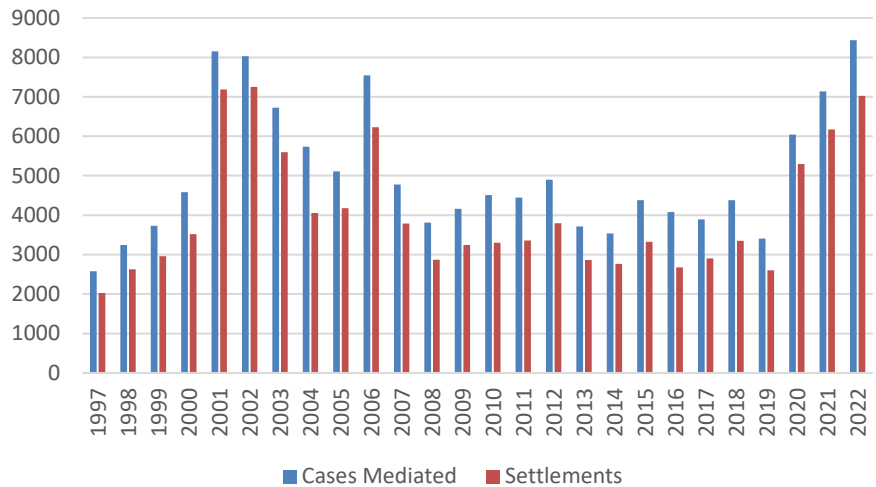

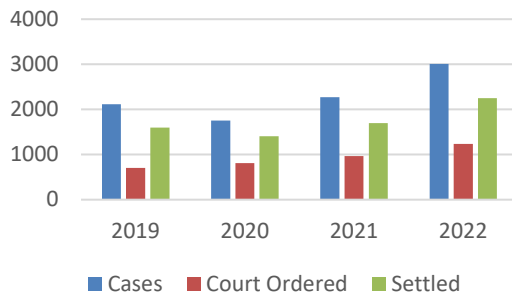

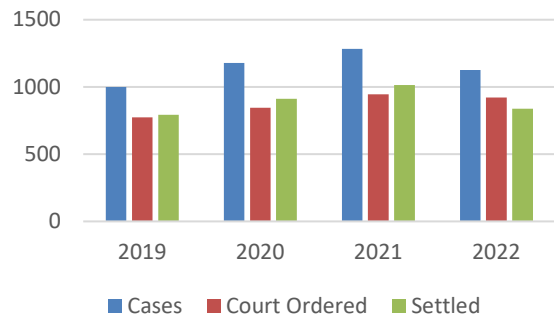

Civil Mediation Non-Divorce



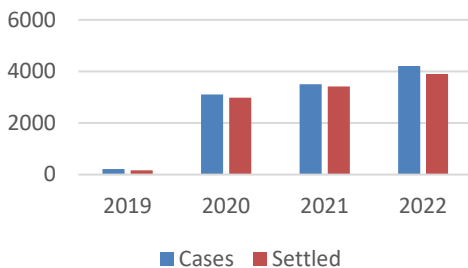

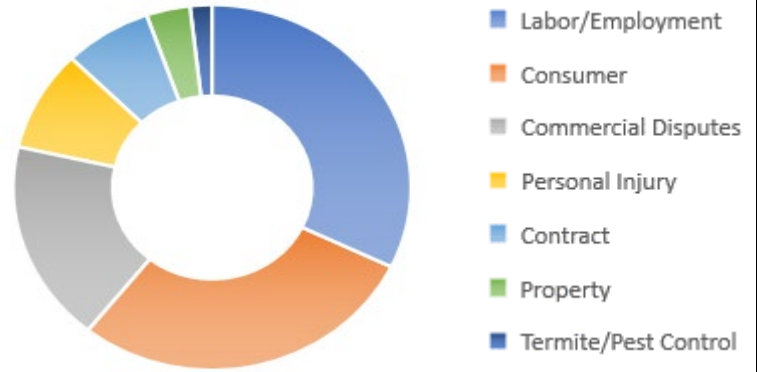

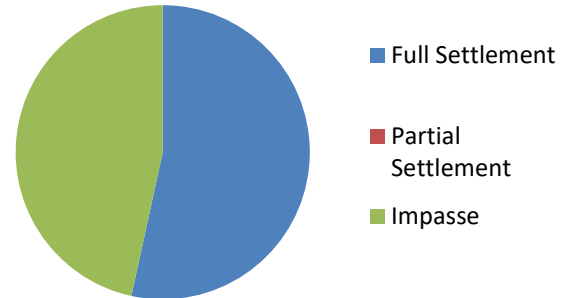

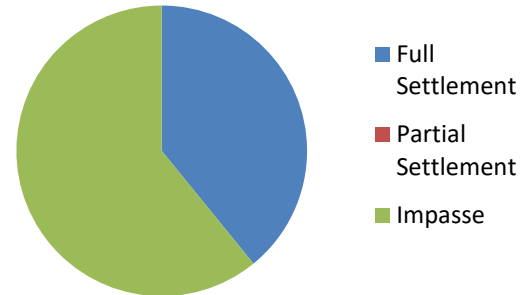
