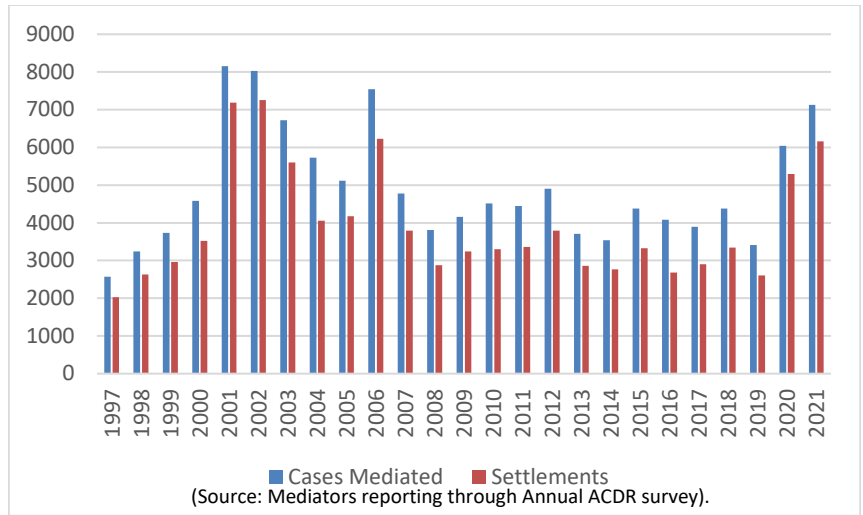

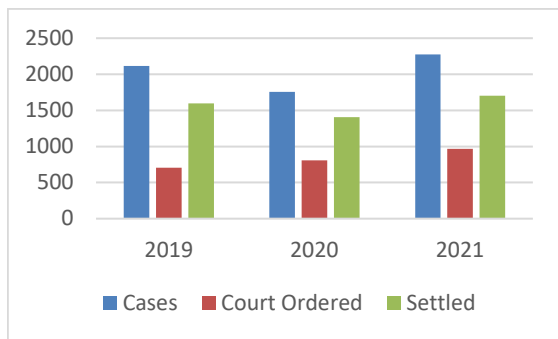

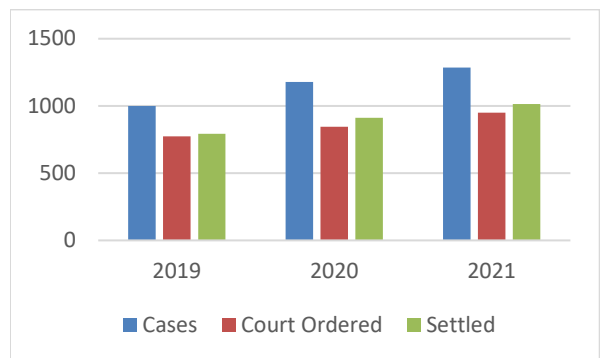


## Civil Mediation Non-Divorce



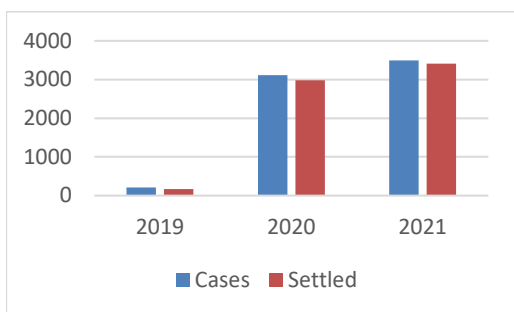

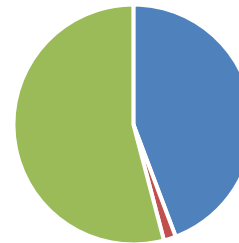

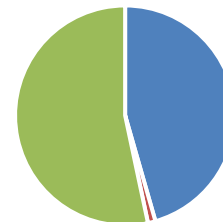
