The American Bar Association Section on Dispute Resolution recognizes the important role of ombuds on the 2nd Thursday of October. This year we were pleased to have representatives of the Alabama Department of Labor Ombudsman program and the Alabama Department of Senior Services State Office of Long-term Care Ombudsman Program join with us as Governor Ivey proclaimed October 13, 2022 at "Ombuds Day" in Alabama. The primary goal of Ombuds Day is to improve public awareness of those who serve as ombuds and to educate the public about their role; explain the wide variety of services that ombuds provide; encourage greater use of ombuds programs and services; and highlight the value ombuds bring to the institutions and constituents they serve. The concept dates to 1809, when Sweden appointed an independent official known as an ombudsman to investigate complaints against government officials and agencies. #### RECENT DECISIONS ALABAMA APPEALS COURTS

## The Lem Harris Rainwater Family Tr. v. Rainwater (Ala.2022) Chief Justice Parker

This case returns to this Court as an appeal in ongoing litigation among four siblings regarding family trusts. Charles Edward Rainwater, Jean Rainwater Loggins, The Lem Harris Rainwater Family Trust, and the Rainwater Marital Trust appeal a final judgment of the St. Clair Circuit Court enforcing a settlement agreement in the litigation. They challenge three aspects of the judgment: its enforcement of the settlement agreement, its denial of a motion to dissolve a prior order enforcing the settlement agreement, and its denial of a motion to quash a garnishment. Because the court failed to hold an evidentiary hearing on enforcement of the settlement agreement, because the prior enforcement order was improper, and because any award on which the garnishment could have been based is being reversed, the court reversed the judgment as to all three aspects.



# FREE FAMILY MEDIATION PROGRAM AVAILABLE TO QUALIFIED FAMILIES THROUGH COURT-ORDERED MEDIATION

The **Parents are Forever Family Mediation Program** provides a *free* family mediator to parents undergoing a divorce, a CS case **or** a custody modification who have minor children. The gross family income must be less than \$60,000.00. This court ordered mediation program uses registered family mediators with the Alabama Center for Dispute Resolution. The parents agree to work with the registered family mediator to develop a financial plan and a parenting plan which was subject to judicial review. Parents will always remain parents to their children and focusing on the future and reduced conflict is important. Fifty Alabama counties have participated in the program. Alabama judges may order the parties into the program or the parties may ask the court to refer them to mediation under the program. # ALABAMA FIRST LANDLORD TENANT MEDIATION PROVIDES FREE MEDIATION SERVICES TO LANDLORDS AND TENANTS

Through the Alabama First Landlord Tenant Mediation Program landlords and tenants work with a *pro bono* mediator on unlawful detainer cases, eviction cases and/or landlord/tenant disputes. Mediators participating in the program must be registered with the Alabama Center for Dispute Resolution to participate in this court-ordered mediation program. This means the mediator has completed a 20-hour and/or 40-hour mediation training course and agrees to comply with the Alabama Code of Ethics for Mediators as well as the Alabama Civil Court Mediation Rules.

Landlord/Tenant mediators may be found at <a href="www.alabamaadr.org">www.alabamaadr.org</a> under the heading Mediators/Arbitrators and using the term "Landlord/Tenant" in the search field for practice area.

If an agreement is reached it is presented to the court. If no agreement is reached the parties will have a trial.

Mediators send a copy of the order to mediation to the Center to obtain a unique case number. The Center sends the mediator an invoice to get paid, a confidential case report and participant feedback forms. These documents are *not* filed with the court. Mediators are paid at an hourly rate of \$100 for no more than two hours of mediation. Any time in excess of two hours is counted as *pro bono* time.

Funding for this program is made possible through grants from the Alabama Law Foundation, the Alabama Civil Justice Foundation and the Alabama Access to Justice Commission. Funds are available through May 2023 on a first-come, first-served basis.
